IMPORTANT NOTICE TO ALL MEMBERS

The benefit of Gift Aid Tax Relief is available to Charitable Societies in respect of donations from UK tax payers (out of their general taxed income) of any amount. The Society can reclaim tax at no extra cost to the donor. In addition, a donor who is a higher rate tax payer can claim further relief in his or her own benefit.
